01	According to the NCVT rule National Apprenticeship certificate (NAC) holder is eligible for the post where required qualification is ITI (NTC) for the particular trade. But I have been rejected in document verification for the same, which is held on 5Feb 2023. So, what is the actual reason of rejection? And what should I do? Note- please refer notice no-3, page no-3.	As per Advt. No. IGCAR/02/2021, the candidate should possess the required qualification as on closing date of application. Whereas, Shri Aman Kumar does not possess ITI certificate as on closing date and hence was rejected at the time of document verification on 05/02/2023. Further, it may also be noted that as per Para 2 of the OM No. DGET-29(1)/97-AP dt. 26/08/1999, the number of years spent during Apprenticeship training after completion of ITI will be considered as Experience only.
