Please refer to your RTI application no. IGCAR/R/E/23/00042 dated 16.05.2023 received in this Centre on 16.05.2023 under the RTI Act. The information sought by you is furnished as under:-

01.	The discretionary powers available with HEAD OPS & HEAD ROD of RFG, HEAD RIOD of RDTG, HEAD CD of EIG, HEAD DFRP, HEAD RDL of RPG, RCL of MCMFG for not implementing and following the orders/ circulars issued by Administrative officer - III or Chief Administrative Officer with concurrence of Director IGCAR in connection to the national holiday C.off, Earned C.off, C.off in the lieu of NDA , C.off in the lieu of NRPSA.	The information sought is interrogatory in nature and does not constitute information under Section 2(f) of the RTI Act, 2005. Also, PIO can provide information which exists in material form and not expected to give any reasons or reply to hypothetical / interrogative questions.
02.	Discretionary powers available with all above-mentioned officials for not implementing the DoP&T OM dated 12.07.2022 regarding night duty allowance endorsed by Under secretary DAE dated 23.02.2022. In that order it is clearly mentioned the work performed by an employee (NGO) in Round the clock shift from 22:00 to 06.00 hrs shall treated as night duty (8.00 hrs) performed. But the above mentioned officials have overruled the OM and denied national holiday C.off when night duty is performed on a declared public/national holiday by mentioning that 22.00 to 00.00 hrs (only 2 hours) duty was performed on that day.	
03.	From the day round the clock shift operation was in practice in IGCAR, once the night shift completed in morning 6.00 am then starts the weekly off. as per the points mentioned in Para 2 the (6 hours duty) that is 00.00 hrs to 06.00 hrs on every night shift will be performed on weekly off only(next day as per 24hrs pattern).any monetary benefits/ c.off of is not provided in this scenario and the benefits are denied purposefully.	

04.	NDA is paid to NGO only upto the basic pay Rs. 43600. But the scientific assistants -C / foreman-A/ technician -G are attending Night duty and performing RTC shift duties without NDA / C.off in the lieu of NDA (8 days per year) based on the BARC order 1/3/05/FRD/to/1707 dated 14.10.2005.	which exists in material form and not expected to give any reasons or reply to hypothetical / interrogative questions.
05.	similarly the NRPSA is paid only to employees attending RTC shift duties upto level 5 of 7th CPC. But the employees such as scientific assistants -C / foreman-A/ technician -G and above are attending RTC without the payment of NRPSA or C.off in the lieu of NRPSA(7 days per year).	
06.	As per the RTI IGCAR/2(110)/2022-23/ADMIN(vig)-813 dated 22.09.2022 and RTI IGCAR/2(114)/2022 23/ADMIN(vig)-890 dated 14.10.2022 the RTC employees are working 30 extra days in a year. and correspondingly earned c.off is provided as a maximum of 15 days based the number of days RTC shift have been attended in the previous year along with other C.off mentioned. But all these orders are applicable throughout the IGCAR. But the above mentioned officials in PARA 1 are denying and not approving and sanctioning the leaves in these categories also rejecting the leaving forcing the employees to apply CL and EL.	
07.	As per the DOPT orders endorsed by DAE, since there is no NDA for scientific assistants -C / foreman-A/ technician -G and above their duty timings shall be changed to I or II general shift timings of IGCAR as the monetary benefits or C.off is not provided.
