1.	What is the procedure for withdrawal of my resignation and joining back the organization, with my accounts still not cleared for month of October, what is the possibility.	Shri. P. Deepak Raj was governed by Temporary Service Rules and not confirmed at the time of his resignation. Shri. Deepak Raj relinquished his post only when the resignation was accepted by the Competent Authority and was relieved of his duties under the said rules. No provision exists for reinstatement under the said rules.
2.	Contacting the admin people of IGCAR, they told me, to join as SO/C again I would have to give OCES program, because there is no provision to join me in the same post which I resigned so the following questions arises, will I have to undergo the training once again after clearing the interview again.	This is not an information under Section 2 (f) of the RTI Act. The applicant is apprised that a citizen's right extends only to seeking information as defined in Section 2(f) of the RTI Act, either by pinpointing the file, document, paper or records etc. specifically by mentioning the type of information as may be available with the specified public authority.

3.	Is there any blacklist for employees resigning DAE that could hinder them trying to join back.	This is not an information under Section 2 (f) of the RTI Act.
