But assistant personal officer in my office asked me for gazette notification and did not accept her updated birth certificate.	This is not an information as defined under Section 2(f) of RTI Act, 2005.  The applicant is apprised that a citizen's right extends only to seeking information as defined in Section 2(f) of the RTI Act, either by pinpointing the file, document, paper or records etc. specifically by mentioning the type of information as may be available with the specified public authority. Only such information can be had under the Act and CPIO under the RTI Act is not supposed to create information or to interpret information or to solve the problems raised by the
