Please let me know the exact reason of Disqualification.my registration no : 46158392 | <p>The information sought by the applicant does not conform to the definition of "Information" under Section 2(f) of RTI Act, 2005.</p> <p>The CPIO is not supposed to communicate the reason why a certain thing was done or not done in the sense of a justification because it is the requisition of information that falls under the scope of RTI Act, 2005. However, it is apprised that the applicant has enrolled for 2 year ITI course in Fitter trade in 2018. Due to Covid-19, the final year examinations were delayed due to which the results were declared on 30.05.2021. As per Clause 4 under General Instruction of Advt. No. IGCAR/02/2021, candidate should possess the required eligibility as on 14.05.2021 (Crucial date for determining age, educational qualification, etc., Hence, the candidate was found not meeting the norms and was disqualified.</p> |
