
Sub: Restrictions for entry of private vehicles to DAE Complex, Kalpakkam.

Reference is invited to this Circular no. IGC/Dir(P&A)/G-26(1)1/2020 dated 30.03.2020 and dated 15.04.2020 imposing certain restrictions for entry of private vehicles to DAE Complex, Kalpakkam.

2. In the light of the revised orders on COVID-19 Infection prevention and control issued by the Revenue and Disaster Management (DM-II) Department, Government of Tamil Nadu vide Notification dated 03.05.2020, the matter regarding the restrictions for entry of private vehicles to DAE Complex, Kalpakkam has been reviewed and the following revised instructions are issued.

- i. Private vehicles (both two wheelers and four wheelers) of employees of IGCAR & BARCF coming for Round-the-Clock shifts will be allowed to enter the DAE Complex w.e.f. **08.05.2020 (Friday)**.
- ii. Private vehicles of the employees of IGCAR & BARCF coming for Round-the-Clock shift duties shall be parked in the green chain linked parking area (opposite to Training School Complex) on the left side of the road leading to IGCAR-BARC Security Gate.
- iii. Private vehicles of employees of IGCAR & BARCF coming for General shift duties will be allowed to enter the DAE Complex w.e.f. **11.05.2020 (Monday)**.
- iv. Private vehicles of the employees of IGCAR & BARCF coming for General shift duties shall be parked at the designated parking area opposite the IGCAR-BARCF Security gate.
- v. A maximum of three persons i.e. the driver of the vehicle + two passengers in the case of Cars/Jeeps and one person in the case of two wheelers only will be allowed to travel in the vehicle.

- vi. Facilities for sanitization of the private vehicles departmentally at the designated parking area are being arranged departmentally. Therefore, all employees are requested to park their vehicles only at the designated parking place.
- vii. In case any vehicle is found parked in any other place, the vehicle will be towed away to the designated parking area.
