6.	Please provide me the reason on why SC/ST candidates are not selected as Liaison Officers in those units.	As per DoPT OM No. 1/7/2009-IR dated 20.05.2011, "the definition of information cannot include within its fold answers to the question "Why" which would be same thing as asking the reason for a justification for a particular thing. The public information authorities cannot expect to communicate to the citizen the reason why a certain thing was done or not done in the sense of a justification because the citizen makes a requisition about information. Justifications are matter within the domain of adjudicating authorities and cannot properly be classified as information" under section 2(f) of RTI Act, 2005. Further, as per section 2(f) of RTI Act, Interrogative/hypothetical questions such as "How/why/when/whether" do not come under the ambit of RTI Act, 2005.
