TOWNSHIP LOCKDOWN NOTICE

In view of the outbreak of COVID-19 in DAE Townships at Kalpakkam, as per the directives from Collector, Chengalpattu District and Tamil Nadu State Government authorities, it has been decided to implement the following restrictions in both the Townships:

DAE Kalpakkam and Anupuram Townships will be under total lockdown starting from 2200 hours of 26.06.2020 for 10 days or until further orders whichever is earlier.

The following Township gates will be closed for all vehicular and pedestrian movement, except duly authorised Departmental/Departmentally hired vehicles and persons with passes by the State officials/Police for Essential Services.

- 1) In Kalpakkam Township, Pudupattinam, Sadras main gates, Oyyali Kuppam gates shall be closed for the movements of the residents/outsiders. All wicket gates will remain closed.
- 2) In Anupuram Township, the Gate Nos. 2 & 6 will remain closed for movements of the residents/outsiders. All wicket gates will remain closed.
- 3) For commuting to/from office by departmental/departmentally-hired buses.

1) In Kalpakkam Township:

- a) All the bus stops in Pudupattinam South Zone will be operational as before.
- b) In Pudupattinam North Zone, employees will access the buses through either 3rd Avenue wicket gate or 4th Street for Tsunami Park bus stop and 1st Street gate for Ladies Hostel bus stop.
- c) Sadras Scientist Apartment East Zone employees will access the Ladies Hostel bus stop.
- d) Sadras East employees can access the AEEC Stores bus stop.
- e) Sadras West employees can access the Sai Baba Temple bus stop.

2) In Anupuram Township:

- a) In the Eastern Sector, all the bus stops will be operational as before. The employees will access the bus stop in front of Gate No.2.
- b) PRP Township employees plying to DAE Site will access the Gate No. 6 bus stop.

Vegetable, milk supply, Gas service and Petrol Bunk services which are managed by AEEC stores will not be affected and available for the residents.

Shops of the townships except those operated by AEEC Stores will be totally closed during the above period of lockdown.

In Anupuram Township, AEEC Stores has been asked to open outlet for provisions on the Western Sector near the Milk Booth. AEEC Stores will have counters at the Milk Booth where orders will be taken as per the schedule that will be displayed by AEEC Stores. Similar arrangements may be made for the PRP Township. Attempts are also being made to make the 'More Shop' at BHAVINI Township to be operational.

Courier service/Online shopping deliveries shall not be allowed inside the Townships.

Employees and their spouse/children/dependents/relatives/friends who are out of station will not be permitted to come into the Township from 2200 hours of 26.06.2020 for 10 days.

Facility Quarantine Centres are being arranged inside the townships at NPCIL Guest House, BHAVINI Guest House, New Guest House/Hostel at Anupuram and Multipurpose Hall at Kalpakkam.

Township residents will not be permitted to venture out in the townships except for medical/family emergencies. Senior members of the family above 65 years of age and children below 10 years of age should not venture out for any purpose.

Residents should not move around in the beaches, parks or at any other recreational facilities.

Any person violating the above measures shall be deemed to have committed an offence punishable under Section 188 and other relevant section of IPC (45 of 1860). Such a person shall, in addition, be proceeded against as per the provisions of the Epidemic Diseases Act, 1897 and Section 51 to 60 of The Disaster Management Act, 2005.

All are requested to co-operate and comply with the above and help in the endeavour to contain the spread of COVID-19.
