
3) Candidates with exceptional qualities, as judged from the interview and by referees' reports, may be given additional increments (maximum 5 increments) at the time of appointment. If additional increments are given, the chairman of the Selection Committee should clearly record (in the minutes) whether these additional increments will count for promotion to next higher grade or not.

4) In cases of Medical Doctors/B.D.S., mandatory internship should not be counted as experience. Candidates with institutional experience should be preferred.

5) In case of MBBS/B.D.S Medical Doctors, the candidates with one year experience may be considered for an additional increment at the time of recruitment.

6) Those recruited as SO(C) / SO(D)/ SO(E), will undergo an appropriate orientation course during the probation period.

7) Candidates can be recruited through an open advertisement or through the Prospective Candidate channel to posts for which specialized qualification or experience in scientific, technological or professional fields is essential.







Jects- Relaxation of upper age limit for departmental candidates for appointment to Group 'A' & 'B' posts.

The undersigned is directed to invite attention to this partment's 0.M.No.4/4/74-Estt(D) dated 9th April,1981, according 1.Which Govt. servents may be allowed relaxation upto the rimum of 5 years in the upper age limit for recruitment to oup 'A' & 'B' posts which are filled through the Union bolic Service Commission (other than those filled on the basis competitive exactations). This concession is admissible to such of the Govt. Servants as are working in posts which are in the same line or allied cadres and where a relationship could be established that the service already rendered in a particular post will be useful for the efficient discharge of the duties of the posts, recruitment to which has been advertised. As per the above mentioned 0.M., decision in this regard rests with the Commission.

that this concession is available to departmental candidates for recruitment to to Group 'A' and 'B' posts which are exempted from the purview of the UPSC and, therefore, recruitment to which is made by the organisations themselves. For example Group 'A' and 'B' posts in para-military forces and scientific /technical / posts in scientific departments fall in this category. As it was not the intention to deny this concession in the cases of this type, it is hereby clarified that the provisions of the above mentioned 0.M. are also applicable to departmental candidates for for Group 'A' & E' posts to which recruitment is made by a body other than UPSC. The administrative Department concerned would be competent to take a decision in regard to the question whether there is a nexus between the duties of the post held by the Govt. servent and those of the post for which recruitment is being made.

3. The Ministries/Department may please bring the above clarification to the actice of all concerned.
