After the completion of two years of training,Candidate absorbed as a Scientific Assistant/C. If any candidate got any higher job in any State Services then that bond can be transferred from that Constituent unit of Department of Atomic Energy to State Government or not? if not then kindly provide copy of the order regarding the same. 2. If yes then kindly provide procedure for transferring bond from the Constituent unit of Department of Atomic Energy to State Government.	The decision on transfer of bond obligations differs from case to case depending upon the terms and conditions of bond.
