1.	<p>I want know about advertisement number igcar-02/2021 stipendiary trainee cat2 recruitment.</p> <p>As given in the advertisement, minimum marks were fixed for qualifying all the trades in the written examination. Similarly, in the skill test too, there should be a fixed number of marks to qualify for all the trades, then why are there different marks for each trade? There should be equality in the result, which does not seem to be equality after seeing the result.</p> <p>I hope reply positive.</p>	<p>This is not an information as defined under Section 2(f) of RTI Act, 2005. However, it is apprised that a cut-off mark is required to decide "Go/No go" in the skill test. The candidates who cleared the skill test are empanelled in order of merit based on the marks secured in Stage-2. The explanatory note on empanelment of candidates to the post of Stipendiary Trainee CAT-II published in the website contains all details.</p> <p>It may also be noted that the public authority under the RTI Act is not supposed to create information or to interpret information or to solve the problems raised by the applicants or to furnish reply to hypothetical questions. Only such information can be had under the Act which already exists with the public</p>

		authority. The public Authorities cannot be expected to communicate the reason why a certain thing was done or not done in the sense of a justification. Justifications are matter within the domain of adjudicating authorities and cannot be properly classified as information.
