Tender document can be obtained if the contractor fulfills the following conditions:

Contractor should have a solvency of the amount equal to 40 % of the estimated cost of work.

Average annual turnover should be 100% of the estimated cost during the last 3 consecutive financial years.

Experience of having successfully completed **similar** works with special reference instrumentation works during the last 7 years ending last day of the month previous to the one in which application are invited should be either of the following.

Three similar completed works costing not less than the amount equal to 40% of the estimated cost. (OR)

Two similar completed works costing not less than the amount equal to 60 % of the estimated cost. (OR)

One similar completed work of aggregate cost not less than the amount equal to 80 % of the estimated cost.

Contractor should have filed Income tax returns for the last three years. Contractor should have Permanent Account Number given by department of Income Tax.

Documentary proof of the above aspects shall be submitted as detailed in the tender document along with the bid failing which the bid will be rejected.

The security deposit at 5% of the gross amount of the bill shall be deducted from each running bill of the contractor till the amount of security deposit works out to 2.5% of tendered value of the work. In addition the contractor shall be required to deposit 5% of the tendered value of the contract as performance security in the prescribed form (as specified in the annexure) within a period of fifteen days of issue of letter of intent.

Tenderer must produce original copy of certificates in support of their experience at the time of request for Tender Document.

Tender will be received up to **14.30 Hrs on 20/07/2018** (or the next working day if it happens to be holiday) at the office of the Director, Reprocessing Group, IGCAR, Kalpakkam and opened on same day at **15.05 Hrs** in presence of attending tenderers.


TENDERS NOT ACCOMPANYING THE FOLLOWING ARE LIABLE TO SUMMARILY REJECTED.

- a) A Deposit at call receipt or demand draft of a State Bank of India or Canara Bank payable at Kalpakkam for the earnest money Deposit indicated above in favour of **P & AO, IGCAR, Kalpakkam.**

NOTE: CASH, CHEQUES AND BANK GUARANTEE FOR THE EARNEST MONEY DEPOSIT WILL NOT BE ACCEPTED.

- b) In case of contractors in the approved list of Public Work Department, Central Public Work Department or Military Engineering Services shall be required to submit the copy of evidence showing the appropriate and eligible class to which they belong. In case of reputed contractors they are required to submit the detailed list of works carried out by them during the last seven years along with solvency certificate and list of machine and man power they possess.
- c) PAN certificate in the latest approved form – Details of GST registration including details of tax office with whom they are remitting this tax.
- d) The tenderer shall be required to place the earnest money and the tender in separate sealed envelope marked '**Earnest Money**' and '**Tender**' respectively and both these envelopes shall then be placed in another sealed envelope and submitted. The envelope containing EMD shall be opened first. If EMD is found to be in order then only the envelope containing the tender shall be opened.
- e) In addition to the above, the security deposit @ 5% of the gross amount of the bill shall be deducted from each running bill of the contractor till the amount to security deposit of 2.5% of the tendered value of the work. In addition the contractor shall be required to deposit 5% of tendered value of the contract as performance security in the prescribed form (as specified in the annexure) within the period of fifteen days of issue of letter of intent.
- f) In addition to above Labour Welfare CESS @ 1% shall be deducted from the gross value of work done from each bill paid to the contractor.
- g) Tenderer to note that the tender with any condition including that of conditional rebate shall be rejected.
