Notice Inviting Tender

1. Sealed Item rate Tenders are invited on behalf of President of India by the Project Manager, NDDP, Chief Engineer NDDP & AUGF, Kalpakkam- 603102, Kancheepuram District, Tamilnadu from Contractors on the approved list of government, CPWD, railways, etc. and other reputed contractors for the work as detailed below. The tenders shall be placed in sealed cover super scribed with the name and tender number.

1. Pre-qualification criteria and requirements for vendors

Experience of having successfully completed similar works during last 7 years ending last day of month previous to the one in which applications are invited should be either of the following:

- i. Three similar completed works each costing not less than the amount equal to 40% of the estimated cost.
- ii. Two similar completed works each costing not less than amount equal to 50% of the estimated cost.
- iii. One similar completed work costing not less than amount equal to 80% of the estimated cost.

2. Tender document can be obtained in person from 06-07-2009 to 13-07-2009 during office hours on written requisition with documentary evidence of having executed the work of similar nature, magnitude and on payment by cash (non refundable) to the Pay &Accounts Officer, BARC Facilities, Kalpakkam-603102, Tamilnadu. Tenders will be received up to 14.30 Hrs on 14-07-2009 by Project Manager, NDDP, Chief Engineer NDDP & AUGF, Kalpakkam and

will be opened on the same day at 15.00 HRS, in the presence of attending tenderers. For any reasons, what so ever, the above- mentioned date happens to be a holiday, the tender will be opened on the next working day.

3. TENDERERS NOT ACCOMPANIED BY THE FOLLOWING ARE LIABLE TO BE SUMMARILY REJECTED.

a) The tender should be accompanied with the Earnest Money Deposits in the form of Deposit at call Receipt or Crossed Demand Draft from State Bank of India / Canara Bank drawn in favor of Pay & Accounts Officer, BARC Facilities, Kalpakkam payable at Kalpakkam.

Note: CASH, BANK GUARANTEE AND CHEQUES FOR EARNEST MONEY DEPOSIT WILL NOT BE ACCEPTED.

b) The tenderer shall be required to place the Earnest Money and the tender in each separate sealed cover. All the covers are to be clearly written as “Earnest Money” and “Tender” on the respective covers. All the two covers are to be placed in another sealed envelope and submitted. The envelope containing the EMD shall be opened first. If the EMD is found to be in order then only the envelope containing the tender will be opened.

4. Security Deposit:

The security Deposit @ 10 % of the gross amount of the bill shall be deducted from each running bill of the contractor till the sum along with the sum already deposited as earnest money will amount to Security Deposit of 5% of the tendered value of the work. Such deductions will be made and held by Government by way of Security at the rate mentioned above in cash or in the form of DD/DCR drawn in favor of Sr. Accounts Officer, BARCF payable at SBI Kalpakkam. (Bank Guarantees will not be accepted in such cases).

In addition, the contractor shall be required to deposit an amount equal to the 5% of the tendered value of the contract as irrevocable Performance

Guarantee within the period specified in the work order or with in 15 days from the date of issue of Work order whichever is earlier failing the Government shall without prejudice of any right or remedy available in law, be at liberty to forfeit the earnest money absolutely.

The performance Guarantee shall be in the form of Demand Draft/Deposit at call Receipts or Bankers cheque obtained from the State Bank of India/ Canara bank in favor of Pay and Accounts Officer, BARCF payable at Kalpakkam.

The performance Security will be refunded to the contractor on completion of the work and recording of the completion certificate in the Measurement Book. However, the Security Deposit recovered from the contractor will be refunded only after the prescribed maintenance period / Defect Liability Period as stipulated in the agreement. The

prescribed maintenance period / defect liability period will commence from the date of recording of completion certificate in the Measurement Book.

5. TERMS OF PAYMENT:

The Engineer will pay the contractor for performance of the work in the following manner:

Progress payments on running measurements taken jointly by the Engineer and the contractor on monthly basis. 100% of the individual items of the individual items of the schedule of rates shall be released every month on progressive running measurements taken jointly by the Engineer and the contractor on fortnightly basis, after satisfactory completion of each item of work specified therein and duly certified by the Engineer. 10% payment of the completed work in stipulated month shall be absorbed as security deposit till cumulative sum of EMD and SD is 5% of the contract amount.

TAXES:

Income Tax @2% on gross value, surcharge as applicable on Income Tax and Education cess @ 3% on I.T and S.C will be deducted from the payments made to you.

TNVAT 4% will be recoverable.

6. The Tender for the work shall remain valid for acceptance for a period of sixty (60) days from the date of opening.

7. For all other conditions, Tender Document may be referred.

8. Project Manager, NDDP, Chief Engineer NDDP & AUGF reserves the right to reject any or all the tenders or to award parts of the works to different agencies without assigning any reasons therefore.
