Sub: **Reopening of Outsourced Pharmacy at DAE Hospital, ATS & KTS – Reg.**

Ref : Circular No. GSO/HOSP/OUTSIDE_PRES/2026/CHSS/871 dated 15.04.2026

Please refer the above Circular regarding Interim Purchase of Medicines by the CHSS beneficiaries, the beneficiaries were allowed to purchase medicines which are not available in DAE Hospital from any registered medical shops and to claim reimbursement.

It is to intimate that the outsourced pharmacy has been established at DAE Hospital, Anupuram and will be functional from 29.04.2026 (FN) onwards. The outsourced pharmacy will be functioning at usual timings and at the same dispensary building. The details of the outsourced pharmacy operating system are given below.

Anupuram Pharmacy (outsourced):

The outsourced pharmacy will be reopened and functioning from 29.04.2026 (FN) onwards as usual at the same location at Anupuram dispensary building.

Kalpakkam Pharmacy (outsourced):

The reopening of outsourced pharmacy at Kalpakkam at the same location will take few more days. Till then, the Prescriptions have to be submitted at the same outsourced pharmacy location at Kalpakkam and the firm will deliver the medicines in the next session at the same location. The medicines for prescriptions submitted in the FN will be delivered in AN, the medicines for prescriptions submitted in the AN will be delivered in the next day FN. In case of any urgency of medicines, the beneficiaries may also collect the medicines directly at Anupuram outsourced pharmacy. After reopening of outsourced pharmacy at Kalpakkam location, the outsourced pharmacy will function as usual at the same location.

The circular regarding the functioning methodology of Pallavaram Clinic Pharmacy will be issued separately.

The medicines prescribed on or after 29.04.2026 will not be reimbursed against the circular issued on 15.04.2026.
