CIRCULAR No. 185/CHSS/HOSP

Sub: Purchase of outside prescribed medicines by CHSS beneficiaries

Ref: Circular No.182/CHSS/HOSP dated 29.09.2023

1. Reference is invited to circular dated 29.09.2023 on the above subject. The approved outsourced pharmacy M/s. Chennai National Pharmacy will be commencing their services both at Kalpakkam/ Anupuram to all CHSS beneficiaries with effect from 04/12/2023.
2. As stated in the circular cited above medicines are to be obtained only from M/s. Chennai National Pharmacy after obtaining the **Not Available** seal from the Hospital Pharmacy at Kalpakkam/Anupuram. Based on the prescriptions by the Medical Officers of DAE Hospital, the Chennai National Pharmacy shall supply the emergency medicines within 24 hours and other non-emergency medicines within 48 hours as prescribed by the Medical Officers of DAE Hospital, Kalpakkam/Anupuram.
3. **CHSS beneficiaries residing in and around Kalpakkam/Anupuram** may therefore note that reimbursement claims being submitted for purchase of medicines with prescription dated 04.12.2023 & beyond **“as not available”** will not be entertained in CHSS Office, DAE Hospital, Kalpakkam
4. If specific medicine is required to be taken immediately which is not available in the outsourced pharmacy, depending upon the sensitivity of ailment/treatment, specific approval on case by case basis will be granted by Medical Superintendent, DAE Hospital for purchase of such medicines through outside medical shop and for reimbursement of claim.
5. CHSS beneficiaries residing outside Kalpakkam and Anupuram areas (like Thirukalukundram, Chengalpattu, Chennai etc.) including retired employees residing at faraway places, will be allowed to purchase medicines from any outside registered pharmaceutical shops based on the outside prescriptions issued to them by DAE doctors and submit reimbursement claim in the prescribed form to the DAE Hospital, Kalpakkam. This will be further subject to fulfillment of the conditions mentioned in the circular dated 29.09.2023.
