TOWNSHIP LOCK DOWN NOTICE

Reference is invited to GSO Circular No.GSO/EMS/2020/939 dated June 26, 2020 placing Kalpakkam Town Ship (KTS) and AnupuramTown Ship (ATS) under lock-down for a period of 10 days starting from 2200 hrs of June 26, 2020.

On review of the lock-down situation in the twin Townships and on the basis of the discussions with the Tamil Nadu State Government officials, it has been decided to extend the lock-down period from 2200 hrs.of July 6, 2020 to 2400 hrs. of July 31, 2020 with the following relaxations in the existing restrictions.

1. The wicket gates of the Township gates will be opened for pedestrians as indicated below:

However, no two-wheeler or four-wheeler will be allowed through any of the gates - KTS/PDPM & Sadras and ATS/Gate 2, 4 & 6.

- 2. All shops of the Townships, **except the Hair cutting saloons**, will be opened from 08.00 hrs. to 18.00 hrs.
- 3. Milkmen with valid passes will be allowed inside the Townships as indicated below:

- 4. Laundry /Dhobis with valid passes will be allowed inside the Townships.
- 5. Newspaper delivery with valid passes will be allowed inside the Townships.
- 6. House maids with valid passes will be allowed inside the Townships.
- 7. Courier service/online shopping deliveries will be allowed up to the designated isolation gates of the Townships

- 8. While all religious places/place of worship shall continue to remain closed for public and religious congregations are strictly prohibited within the Townships, Priests/Pastor/Imam would be allowed for daily rituals temples/churches/mosque.
- 9. Shuttle services will ply between the two townships at fixed intervals for CHSS beneficiaries to avail medical services.
- 10. Shuttle services between West (Near SBI ATM) and East (Near Hospital gate) sides of the Anupuram Township will continue to operate.
- 11. Limited construction activities may be permitted at ATS.

All other restrictions put into effect from 26.06.2020 shall continue.

Movement restrictions in the night as per the orders of the Tamil Nadu State Government will prevail upto 31.07.2020 as the Section 144 of Cr.PC continues.Any person found violating the lock-down measures shall be deemed to have committed an offence punishable under Section 188 and other relevant section of IPC (45 of 1860). Such a person shall, in addition, be proceeded against as per the provisions of the Epidemic Diseases Act, 1897 and Section 51 to 60 of The Disaster Management Act, 2005.

All are requested to cooperate and comply with the above instructions and help in the endeavour to contain the spread of COVID-19.
