TOWNSHIP LOCK DOWN NOTICE

Reference is invited to GSO Circular of even No. dated July 6, 2020 extending the lockdown period at Kalpakkam Township (KTS) and Anupuram Township (ATS) upto July 31, 2020.

On a review of the lock-down situation in the twin Townships and on the basis of the directives of the Tamil Nadu State Government and discussions with State Government officials, it has been decided to extend the lock-down period at KTS and ATS upto 2400 hrs. of August 14, 2020, or until further orders, with minor relaxations as follows:

 The wicket gates of the Township will be opened for pedestrians as per the timings indicated below:

However, NO two-wheeler or four-wheeler of the residents of the Townships will be allowed through any of the Gates - KTS/PDPM & Sadras and ATS/Gate 2, 4 & 6. As being followed now, only Departmental vehicles and Departmentally hired vehicles shall be allowed entry to and exit from the Townships.

- The Hair cutting saloons of the Townships shall function duly following the COVID protocols between 0800 hrs and 1800 hrs.
- 3. MAPS, being a generating station and PFBR being in an advanced stage of commissioning, both MAPS and BHAVINI may take unit-specific decisions regarding augmentation of attendance of employees as necessary and intimate GSO in order to facilitate transport arrangements, if needed.

All other restrictions put into effect from 26.06.2020 as modified vide GSO Circular dated 06.07.2020 shall be continued. As directed by the State Government, complete lockdown shall be followed in the Townships on Sundays.

Movement restrictions in the night as per the orders of the Tamil Nadu State Government will prevail, as the Section 144 of Cr.PC continues. Any person found violating the lock-down measures shall be deemed to have committed an offence punishable under Section 188 and other relevant section of IPC (45 of 1860). Such a person shall, in addition, be proceeded against as per the provisions of the Epidemic Diseases Act, 1897 and Section 51 to 60 of The Disaster Management Act, 2005.

All are requested to cooperate and comply with the above instructions and help in the endeavour to contain the spread of COVID-19. Usage of face masks and social distancing are compulsory in the Townships. Spitting in the public places within the Townships is also strictly prohibited.
