CIRCULAR NO. 15/2020

Sub: <u>Preventive measures to be taken to contain the spread of Novel</u>

<u>Corona Virus Disease (COVID-19) - social distancing - reg.</u>

In continuation to Circular No. 12/2020 & 13/2020, the following additional guidelines are being issued in light of the proposed territorial restrictions by Tamil Nadu State Government from 1800 hours of 24.03.2020 to 0600 hours of 01.04.2020 :

- 1) All the gates including wicket gates of both the townships will be closed till 1st April, 2020. Access through these gates will be restricted only for accessing basic needs and essential services.
- 2) Residents are required to stay at home and come out only for accessing basic needs and essential services and strictly follow social distancing norms issued by State and Central Authorities, namely maintaining a distance of 1 meter or 3 feet, etc.
- 3) Any congregation of more than five (5) persons in public places is prohibited.
- 4) Residents should not move around in the beaches, parks or in any other recreational facilities.
- 5) Shops that cater to essential commodities which are under the exempted categories shall ensure that there is no crowding at any given time. The premises shall be cleaned and disinfected three times daily. They shall also ensure that sanitizers are provided at the entrance for all customers.
- 6) Any person found violating the above measures shall be deemed to have committed an offence punishable under Section 188 and other relevant sections of Indian Penal Code (45 of 1860). Such a person shall in addition be dealt with under the provisions of the Epidemic Diseases Act, 1897&The Disaster Management Act, 2005.

7) The restrictions imposed vide earlier circulars shall continue to be in force.
