CIRCULAR NO. 16/2020

Sub: Preventive measures to be taken to contain the spread of Novel
Corona Virus Disease (COVID-19) - regarding

Reference is invited to circular No. GSO/Admn/circular/2020/481 dated 31/03/2020. In this connection, it has been decided that in order to strictly comply with the restrictions in the territorial jurisdiction imposed by the State Government of Tamil Nadu under Section 144 of CrPC and facilitate the implementation of the instructions in letter and spirit, the following measures are being implemented in the townships at Kalpakkam/Anupuram with immediate effect and until further orders:

- Township gates will be closed for all vehicular and pedestrian movement, except duly authorised Departmental/Departmentally hired vehicles. However, this will not be applicable to Round-The-Clock and Essential Services Employees of MAPS commuting to / from MAPS, as Essential Service at MAPS is exempted as per the TN Notification Number G.O.(MS) NO.152 dated 23/3/2020 Clause F(i) "Electricity Generation, Transmission and distribution".
- Township residents and DAE employees are once again advised not to venture out of the Townships with or without their private vehicles. Only Employees/Residents with valid permits issued by the StateAuthorities will be allowed to exit and enter the township gates, after due verification of the same.
- 3) CISF flying squad will operate in both the townships to periodically monitor and ensure minimum movement by residents.
- 4) The advisories issued vide earlier circulars shall continue to be in force.

All the residents are requested to cooperate with Security, CISF personnel and Police in order to strengthen our efforts to contain the spread of (COVID-19).
