CIRCULAR No. 201/CHSS/HOSP

Subject: Issue of online appointments for specialist doctors – reg.

With a view to enhance patient convenience an online appointment system is introduced for **specialist doctors** at Kalpakkam & Anupuram hospitals as well as clinics at IMSc Taramani & DAE nodal Centre Pallavaram, Chennai from **December 8, 2025 onwards**. Beneficiaries can login using their registered email id and book appointments for self and dependent family members. Booking of appointment will start from 5 PM of 5th December 2025 for consultation date 08-12-2025.

Link of online appointment will be available on the hospital portal (<https://chss.igcar.gov.in/>). Also it has been decided to provide appointments up to 5 days in advance. In urgent / emergency cases, **not routine cases**, consultation with the concerned specialists / department will be arranged by General Duty Medical Officers at Kalpakkam & Anupuram after clinical assessment and need of patient.

In view of introduction of online appointments, the registration counters at Kalpakkam and Anupuram hospitals will function from 9.00 AM as usual and will provide only current appointments (if available/vacant) for walk-in patients.

Also it is advised that for general ailments and regular routine medications the patients should consult General Duty Medical Officers (GDMO) available round the clock at Kalpakkam and Anupuram hospitals. Current appointments shall be available for GDMO's at registration counter / automatic token issuing machines (kiosks). Long term routine / regular medicines for chronic ailments prescribed by the specialists and entered in Drug Cards can be issued for two months by duty doctor. Appointments of specialist doctors for collection of regular medicines purposes should be avoided.

In case of non availability of the concerned specialist for any unforeseen / unavoidable circumstances, the patients will be **intimated by email to their registered email id**. Patients have following options in these circumstances:

- (i) Book online appointment on next available date

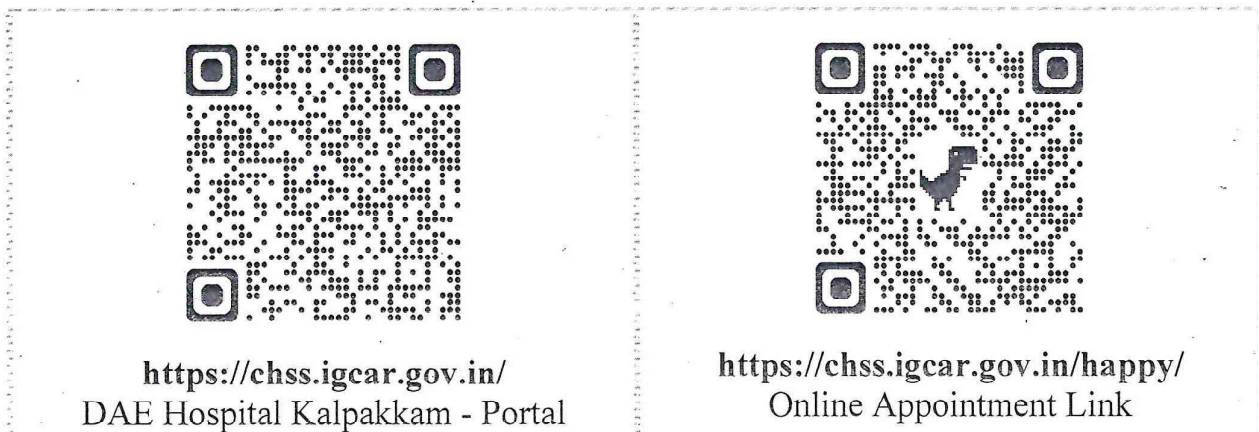
- (ii) Consult another available specialist in the same department by visiting registration counter
- (iii) Consult available medical officer on duty at the hospital

As per the circular no. 198/CHSS/HOSP dated Oct. 28, 2025, five current appointments reserved for senior citizens can be taken from the registration counter between 9 to 11 am (morning session) and 2 to 3.30 pm (afternoon session).

Note-

1. Beneficiaries are requested to honour their appointment date and time.
2. Online appointments will be available up to 12.00 pm (forenoon session) and till 4.30 pm (afternoon session) for the current date.
3. Unregistered beneficiaries are requested to register in order to use online appointment.
