Subject: Recruitment for the post of Security Guard against Advt. No. IGCAR/02/2021

With reference to Advertisement No. IGCAR/02/2021, applications were invited for the post of Security Guard (No. of posts:02) reserved for Ex-Servicemen.

In this regard, the selection process was conducted between 16/12/2021 and 18/12/2021 at Perarignar Anna District Sports Stadium, Kanchipuram wherein the Physical Endurance Test comprising of Level-1: Physical Standards Test followed by Level-2: Physical Test Events was scheduled on 16/12/2021 & 17/12/2021 for a batch of 445 candidates on each day. Subsequently, the candidates qualifying the physical standards in Level-1 and all the events in Level-2 were shortlisted for Level-3: Written Examination held on 18/12/2021.

Shri D. Gnana Prakash scoring the second highest marks (51 marks) in the Written Test had failed to produce the original Educational Certificates namely SSC, HSC and B.Sc. (as mentioned by the applicant during filling of Online Application) at the time of Document Verification held prior to the Stage-3: Written Examination and was allowed to appear for the written test after obtaining an Undertaking stating that the necessary documents would be produced whenever called upon. Hence, an intimation was sent vide email and letter dated 28/01/2022 to produce the Original Documents on 31/01/2022. As he failed to turn up on the said date, a reminder was sent vide email dated 31/01/2022 to report on 02/02/2022. However, the candidate has neither reported on the said dates nor produced the required documents. Hence, cancellation of candidature of Shri D. Gnana Prakash was issued vide letter no. IGC/Rect/1(2)(8)/2019/157 dated 24/02/2022.
