Further, the area of research, as proposed to be pursued should be relevant to the mission programmes of the Centre and expertise should be available with the institute wherein it is proposed to be pursued.
2.	Also provide information whether higher study policy is same in all institute/units of DAE i.e. BARC, RRCAT, IGCAR etc.,	IGCAR has a policy indicated above.
3.	Provide information about complete procedure or formality for doing PhD from an external Institute of DAE like an IIT/NIT, for the scientific officers working in DAE.	The scientific officer interested in pursuing his higher studies in an external institution needs to make an application to his recommending authority indicating clearly the need, linkage to departmental programme along with the details of faculty in that Department who can be a co-guide. The recommending authority needs to put up the case to the Group Board and after approval to the IGC Science Council for final approval.
