## **AUCTION NOTICE No: IGCAR/CEG/CMWD/CMBPS/01/2025**

- Standing live / dead assorted trees at various locations in DAE / IGCAR plant site, Kalpakkam are proposed to be disposed off by **Public Auction at 14.30 Hours on 29/07/2025** as is where is basis. Auction will be conducted by the authorized Officer-in-charge at the Department premises, CDO, IGCAR.
- The location of the Standing live / dead trees to be cleared / disposed in auction will be indicated by the Head, CMBPS, IGCAR, Kalpakkam, in his office at CDO at IGCAR and can be inspected by the intending bidders at the above office during office hours on any working day between 14/07/2025 to 22/07/2025 during the timing of 9.00 am to 5.30 pm.
- Those desirous of participating in the auction will have to deposit Rs.5600/- as Earnest Money Deposit in form of DD or Bankers cheque in favour of Pay & Accounts Officer, IGCAR payable at SBI or Canara Bank, Kalpakkam, along with submission of auction bid. The deposits of the unsuccessful bidders will be refunded at the close of the auction.
- 4) The successful bidder will be required to deposit a minimum of 50% of the bid value of the standing live/dead trees within 48 hrs of the close of auction. This amount will be required to be deposited in the form of DD or Bankers cheque in favour of Pay & Accounts Officer, IGCAR payable at SBI or Canara Bank, Kalpakkam. The EMD remitted vide para 3 above will be reckoned as part of the deposit.
- 5) In case the successful bidder fails to deposit the money as per para 4, the EMD submitted as above will be forfeited to the department and reauction will be taken up.
- 6) The Successful bidder shall deposit balance of the bid value within four working days from the date of intimation confirming the sales, failing which the entire amounts deposited vide Para 4 above will be forfeited to the department and resale auction will be taken.

- 7) In addition to the bid value, the successful bidder shall have to deposit a caution deposit Rs. 20,000/- or of 10% of bid value whichever is higher. (This amount will be refunded after successful completion of all works as per conditions of bid notice).
- 8) In case the sales are not confirmed by the Accounts officer, IGCAR the amount deposited vide para 3 will be refunded to bidder and no claim on any account will be entertained.
- 9) Applicable Goods and Service Tax (GST) shall be payable by the bidder and produce the documentary/challan proof to Officer –in- charge and Accounts officer, IGCAR before transportation of timber. GST or any other tax applicable as per extant orders in respect of this work shall be payable by the Bidder and Government will not entertain any claim whatsoever in respect of the same.
- The Standing live/dead trees are to be cleared within **1 (One) year** from the date of confirmation of the sale (as per the Instructions of Engineer-in-charge). The successful bidder will have to arrange to get the cut timber to the road side and load the same into the lorries at the main road. Cutting, removing, loading and transporting of timber will be permitted between 9.30 am to 5.30 pm on working days. On any occasion the successful bidder or any of his employees should not cut or cause damage to the standing tree especially young trees in the adjoining area not covered by the present auction. In case any such cutting, damages are noticed by the department, the department will be free to cancel the auction and forfeit the deposits of the successful bidder including caution deposit. The decision of the department in this respect will be final and binding on the successful bidder.
  - 11) The Root of cut trees should be excavated and removed to the satisfaction of Engineer-in-charge failing which the cut trees will not be permitted to be taken out.
  - 12) In case if any existing service line like water supply, drainage lines and any other part of compound wall are getting damaged during the course of cutting or removal of trees and roots, the same shall be rectified or restored by the bidder at the cost of the bidder.
  - 13) Such of those fully agree to abide by the above terms and conditions will be permitted to participate in the auction. The successful bidder will make his own arrangements for guarding the cut timber during the time between the date of auction and final removal of timber from the site and department accepts no responsibility for any loss / pilferage during the above period.

- 14) Any standing live / dead tress covered in this auction found not cut and removed within stipulated time in para 10 above will become the property of the department and the successful bidder will have no right whatsoever on the materials disposal by public auction.
- 15) The Officer-in-charge of auction reserves the right to reject or accept the bids without assigning any reason therefor.
